PB-08-20 - Bell Atlantic - 3 Cemetery Drive

Jared Lusk was present to address the board on behalf of the application. He explained that they are looking to build a wireless communications tower on land that is being leased from the town. The board discussed screening for the new tower, a paved driveway next year and the timeframe of the lease. The application was tabled for two weeks.

PB-09-20 - Macneal - Canandaigua Rd/Gananda Parkway

Steve MacNeal was present to address the board on behalf of his application. He explained that the application changed from a 6,000 square foot building down to 4,800 square feet. He mentioned there would be a pizzeria on one side and a brewery on the other with seating in the middle. The board expressed concerns about the appearance of the building from Gananda Parkway. They discussed the possibility of adding windows, changing the roof style, dormers over the doors, and the colors of the building. The application was tabled for two weeks.
