- Chris Countryman stated parks are cleaned up and bathrooms are open for the season. Barry Plastics helped with cleanup at the cemetery.
- Paul Harkness stated he received the check from for the total loss of the ambulance. It was
 talked on if the new ambulance would be purchased outright or leased. There is a grant coming
 for the new stretcher. It was talked about leasing the new ambulance, paying for graphics and
 radio out of total loss funds and put remaining funds into reserves.
- Mr. Fulvio talked about the purchase on Main St. A survey needs to be completed before
 proceeding. Mr. Allen is soliciting quotes. Anticipated closing is mid-June. The Town is working
 on a grant to move lights by Gravino Park. A second grant is in the works to do Gravino Park.
- Mr. Fulvio talked about MOU, the regional sewer plant. Three questions were asked; how are the
 parties involved going to contribute toward the cost? What will be done with the excess capacity?
 What is the scope of the project? The application deadline is potentially set for end of June.
 Councilman Kenyon stated he would possibly like to see sewer charges collected from Capital
 Charges to go into a reserve.
- Chief Colella stated there is prescription collection this coming Saturday from 10-2PM.
- Councilman Maul stated bank reconciliation are done through December 2017. He recommended books to continue to be reviewed approximately four hours per month until everyone is comfortable in their position.
- Scott Allen spoke about the sewer district. He stated Money should be put into a reserve to fix
 extras that could come along that belong to the Town of Macedon. An example would be piping
 or pumps going to water treatment. He is looking at getting a master plan in place and met with
 engineers in reference to master plan.
- Supervisor Pagano talked about 05/2017 resolution to purchase 79 Main St. The Town is waiting on purchase offer. Once the purchase offer has been obtained, then the resolution can be passed.
- Ms. Braun stated the Time Warner Bill still state "Village of Macedon". They have been contacted in regards to this. She stated concern for the road in front of Macedon with the shape it is in. It is a state road. A marker is being installed at 39 Main St. It is the corner of Daansen and Macedon Center Rd. The academy is scheduled for cleanup Saturday at 9AM. She is working with library director and obtaining a grant for Bullis collection. Planning a cemetery tour on June 2nd, rain date-June 9th.
- Supervisor Pagano mentioned she just got back from conference and spoke with many people about various projects Macedon has in the works.

 Councilman Babcock stated he met with library board to talk about the lease. Helen called a probono lawyer for feedback. There's a need for paint and new floors. A grant writer looked at the floors. Gary from the library board would like to present to the Town Board and public about how their year has gone so far. He is looking to speak at May 10, 2018 Board meeting.

At this time, the floor was open to the public. Resident spoke about the deadline in regards to Waste Management and odor control. She further asked to speak at May 24, 2018 and have it entered into the minutes. Resident asked to let individuals from neighboring towns speak at the May meeting because of their knowledge.
