- > Senator Helming has awarded the Town of Macedon \$60,000 to go towards Gravino Park bathrooms and concession stand. The Town is still applying for the LWRP grant for the improvements at Gravino Park.
- Memorial Day Parade will be held at the Canal Park on May 28th at 11:00am
- The Town received a letter regarding the Butterfly Trail. The highway department will take over the mowing of the trail.
- ➤ Highway Superintendent stated that the Sweeping of roads is near completion.
- ➤ Councilman Maul regarding a email that was he sent to the Board regarding Amazon website fee's. The fee is around \$5 a month. Councilman Maul is proposing that we continue using Amazon website services and he will bill the Town \$60 which would cover the Town website for the entire year.
- Councilman Maul stated that he does a lot of work at Bullis Park and he sees that several residents turn down the driveway that is a dead end which creates a lot of dust. Councilman Maul proposes that we get a sign that states that this is not the main entrance driveway.
- > The Board authorizes the Town Attorney do a draft for the Solar Opt-Out.
- Councilman Maul has been speaking with the Chief of Police to bring the Police Department website to the Town website as well as the ambulance website.
- ➤ The MOU is evolving regarding the Joint Sewer project with the Town of Macedon, Village of Palmyra, Town of Marion and WCWSA stated Councilman Kenyon. Councilman Kenyon stated that once this new plant is in operation then the Board would need to figure out what will be done with the land and the existing buildings.
- > The Town Clerk brought up to the Board regarding placing a drop box on the exterior of the Town Hall for water bills, capital charges and dog licenses which would add another option for the residents.
- Town Attorney David Fulvio shared with the Board and the public that he has looked into FAFE giving a presentation to the Board at the May 24, 2018 and due to the FAFE group being represented by legal counsel and has stated intent to litigate, it is considered unethical to have FAFE make a presentation unless the Town Attorney and FAFE Attorney are present.
