**RESOLUTION NO. 160 (2018) NOTICE OF RESOLUTION - SUBJECT TO PERMISSIVE REFERENDUM**

Notice is hereby given that at a duly scheduled meeting of the Town Board of the Town of Macedon, Wayne County, New York, duly held at the Macedon Town Hall, located at 32 West Main Street, Macedon, New York, on the 12th day of July, 2018, at 7:30 P.M., the Town Board of the Town of Macedon duly adopted the following resolution pursuant to Section 220 of the New York State Town Law, which is subject to a permissive referendum:

WHEREAS, on April 17, 2018, the Town entered into a purchase and sale contract with Canandaigua National Bank whereby the Town agreed to acquire vacant land located on Main Street and identified by Tax Numbers 63111-05-017913 and 63111-05-031910 (hereinafter "Main Street property") for a purchase price of \$10,000; and

WHEREAS, the Town of Macedon anticipates utilizing the property for one or more of the purposes set forth in Section 220 of the New York State Town Law; and

BE IT RESOLVED, the Town hereby accepts the conveyance of the aforesaid Main Street property from Canandaigua National Bank; and

BE IT FURTHER RESOLVED, the Town Supervisor is authorized to execute any documentation and pay all recording fees necessary to effectuate said purchase and acquisition, subject to attorney approval; and

BE IT FURTHER RESOLVED, this resolution is subject to permissive referendum and the Town Clerk shall publish and advertise this resolution as such in the manner prescribed by law.
