### RESOLUTION NO. 234 (2018) REGIONAL WASTEWATER TREATMENT PLANT PROJECT

WHEREAS, the Town of Macedon, Town of Marion, and Village of Palmyra (hereinafter collectively referred to as the "Participating Municipalities"), each currently own wastewater treatment plants that are currently or will be in need of substantial capital improvements and/or replacements to maintain current operations; and

WHEREAS, in lieu of upgrading and continuing to independently operate such existing wastewater treatment plants, the Participating Municipalities have discussed and memorialized their intent to work together cooperatively to develop a single facility and conveyance system that would meet their collective needs pursuant to that certain Memorandum of Understanding Regarding The Wayne County Water And Sewer Authority 2018 Regional Wastewater Treatment System Improvements Project, entered into and effective as of May 1, 2018 (the "MOU"); and

WHEREAS, such facilities would be owned and operated by the Wayne County Water and Sewer Authority (hereinafter, the "Authority") for the benefit of "Users" within the Participating Municipalities and certain "Out-of-Village Users" within the Town of Palmyra receiving wastewater service from the Village of Palmyra; and

WHEREAS, the Authority desires to design, construct and operate a western regional wastewater conveyance system and treatment facility with a capacity to treat 1.75 million gallons per day of wastewater and to provide wastewater, conveyance, treatment and related services for the benefit of the Participating Municipalities; and

WHEREAS, each of the Participating Municipalities desires to participate in the project and to receive wastewater conveyance and treatment services from the Authority for consideration and is willing to (1) pay the NO. 21 Page 2

Authority its respective "Pro Rata Share" of the cost of the design, procurement, acquisition, financing, construction and permitting of the project, (2) authorize the Authority to directly invoice and collect from the Users the cost of operating and maintaining the project, and (3) transfer to the Authority ownership of specified real property, equipment and physical access to specified lands in consideration of the Authority providing wastewater conveyance and treatment services to the Participating Municipalities; and

**WHEREAS**, the Authority is willing and has determined to design, finance, procure, construct and operate the Project so long as each of the Participating Municipalities shall pay their respective Pro Rata Share of all costs in connection with the design, procurement, acquisition, financing, construction and permitting of the Project and the Users shall pay for the operation and maintenance of the Project improvements; and

**WHEREAS**, the Participating Municipalities and the Authority desire to enter an Intermunicipal Agreement setting forth the parties' respective rights and obligations with respect to the project; and

**NOW, THEREFORE, BE IT RESOLVED**, the Town Board is hereby authorized to execute the Wastewater Treatment System Improvements and Services Agreement, between the Wayne County Water and Sewer Authority and the Town of Macedon, Town of Marion, and Village of Palmyra, to be effective December 1, 2018.
