PUBLIC HEARING NOW OPEN FOR PUBLIC COMMENT

Councilman Maul did a presentation on the budget. A Board member from the Library Board asked why the money was taken out of the budget of \$1700 for painting of the community room and hallway. The Board stated that they would put that back into the budget.

A resident asked the Board why the incoming Supervisor's salary was increased by 23%. The Board explained that the incoming Supervisor requested an amount and the Board negotiated a different rate which was not what the incoming Supervisor had requested. The question was then asked why the current Supervisor was being paid less and the Board explained that the amount the current Supervisor was making was what was negotiated when the Supervisor stepped into the position. The Board identified the reasons they felt justified the amount of salary presented in the budget. They stated that the incoming Supervisor has 26 years' experience on the Board, 18 yrs as Deputy Supervisor, has a Master's degree in Administration and has worked in the capacity of an administrator for the Palmac School District.

A resident asked the Board about an email that was sent to the Supervisor requesting the 2018 AUD and as of the night of the Board meeting the resident had not received any feedback from the Supervisor or any Board member with the exception of Mr. Kenyon and Mr. Maul. Supervisor Pagano stated that they were making corrections on the AUD and would let the Clerk know when it is complete which it will then be filed in the Town Clerk's office for review from the public.

A resident asked if the Town was still budgeting money for the Palmyra Community Center as they did not see it in the proposed budget. The Board stated that it was still in the budget in line 121 under A7310.401 for the Palmyra Community Center.
