LOCAL LAW NO. 1 (2020) A LOCAL LAW AMENDING MACEDON TOWN CODE § 23-5 REGARDING VACATION TIME AVAILABLE TO TOWN EMPLOYEES

Be it enacted by the Town Board of the Town of Macedon as follows:

Section 1.

Macedon Town Code § 23-5(A)(1) is hereby amended to read as follows:

- (1) All full-time employees shall be entitled to annual vacations with pay based upon their years of service and employment as follows:
 - (a) 40 hours after one full year of employment.
 - (b) 80 hours after two full years of employment.
 - (c) 88 hours after four full years of employment.
 - (d) 96 hours after five full years of employment.
 - (e) 104 hours after six full years of employment.
 - (f) 112 hours after seven full years of employment.
 - (g) 120 hours after eight full years of employment.
 - (h) 128 hours after eight full years of employment.
 - (i) 136 hours after 12 full years of employment.
 - (j) 144 hours after 14 full years of employment.
 - (k) 152 hours after 16 full years of employment.
 - (I) 160 hours after 18 full years of employment.
 - (m) 200 hours after 29 full years of employment.

Section 2.

Macedon Town Code § 23-5(A)(7) is hereby amended to read as follows:

(7) All vacations must be taken in the calendar year during which the employee becomes entitled to the vacation, except up to 40 hours of unused vacation time may be carried over from the year accrued to the succeeding year.

Section 3.

This local law shall go into effect immediately upon filing with the Secretary of State.
