WHEREAS, the Town Board, on behalf of Macedon Consolidated Sewer District No. 1 and the Hamlet of Macedon Sewer District, entered into an intermunicipal agreement with the Wayne County Water and Sewer Authority ("WCWSA"), the Town of Marion, and the Village of Palmyra (with the consent of the Town of Palmyra) (collectively, "Original Participating Municipalities"), dated December 1, 2018 and revised by Addendum No. 1, dated and effective as of January 1, 2019 ("Original IMA"), setting forth the parties' respective rights and obligations pertaining to the future construction of a regional wastewater treatment plant, sewer mains, pump stations, and additional improvements connected thereto ("Regional Plant"); and

WHEREAS, the Town of Walworth subsequently expressed its desire and intention to participate in the Original Project, as expanded and enhanced to meet the needs of the Town of Walworth, conditioned upon the receipt by the Authority of additional funding commitments, by entering into the Memorandum Of Understanding Regarding The Potential Participation Of The Town Of Walworth In The Wayne County Water And Sewer Authority's Western Regional Wastewater Treatment Systems Improvements Project with the Authority (with the consent of each of the Original Participating Municipalities), effective as of June 1, 2019, which was amended and restated by Agreement dated and effective as of September 13, 2019 (the "Walworth MOU"); and

WHEREAS, the Authority has since received such additional funding commitments for the Original Project, as expanded and enhanced to meet the needs of the Town of Walworth, (the "Project"); and

WHEREAS, the Town of Walworth wishes to fully participate in the Project as a "Participating Municipality" on the same basis as the Original Participating Municipalities with the same rights and subject to the same obligations of the Original Participating Municipalities; and

WHEREAS, the Parties desire to (i) amend and restate the 2018 IMA setting forth the parties respective rights and obligations with respect to the Project; and

NOW, THEREFORE, BE IT RESOLVED, the Town Board, on behalf of Macedon Consolidated Sewer District No. 1, the Hamlet of Macedon Sewer District, and the Gananda Sewer District, is hereby authorized to execute the Amended and Restated Wastewater Treatment System Improvements and Services Agreement, by and between the Wayne County Water and Sewer Authority and the Town of Macedon, Town of Marion, Village of Palmyra, Town of Palmyra, and Town of Walworth, to be effective April 1, 2020; and

BE IT FURTHER RESOLVED, the Town Board, on behalf of Macedon Consolidated Sewer District No. 1, the Hamlet of Macedon Sewer District, and the Gananda Sewer District, is hereby authorized to enter into the Western Regional Wastewater Treatment Plant Project 2020 Amended and Restated Control Agreement, by and between the Wayne County Water and Sewer Authority and the Town of Macedon, Town of Marion, Village of Palmyra, Town of Palmyra, and Town of Walworth, to be effective April 1, 2020.
