Chris Countryman stated that barricades have been placed at Gravino and Bullis parks at all entrances letting residents know that the parks are closed until further notice due to COVID 19.

Scott Allen has received complaints that Lowes was not following the COVID 19 rules. A Notice of Violation & Order to Remedy was issued to Lowes. Lowes has rectified the issue and are following the COVID rules.

Dr. Richard Lu and Rachel Clar from Abundant Solar spoke to the Board regarding the solar issues on Wilson Rd. Dr. Lu explained that RBI Solar Mounting system was a first generation tracking system. A failure of components in the tracking system caused damage to modules and the main drive shaft on site. RBI removed damaged racking, broken panels and installed the necessary new components. Dr. Lu stated that as this work was underway Governor Cuomo issued his non-essential work stoppage and RBI had to pull their crew off site before they were able to clean up the debris and finalize repairs. Full operation of the site should be achieved within 3 to 4 weeks following return to site.
