 Wayne County Bicentennial Committee member Gene Bavis gave a Presentation on the Wayne County Bicentennial 2023 and touched on some highlights that are being worked on as well as going on.

Wayne County was established from Ontario and Seneca Counties in 1823. It is one of 15 counties across the United States named after a Revolutionary War Hero, Brigadier General Anthony Wayne.

When Wayne County was formed, there were several governmental appointments – Clerk, Deputy Clerk, two Coroners, Sheriff, District Attorney and Judge. The first meeting of the Board of Supervisors was held in October 1823, 6 months after the formation of the County.

Lyons became the county seat in 1823 and soon after the courthouse was built. It was a two-story brick building in the center of the Lyons Village Square. The jail was in the basement, the county offices were on the main floor and the courtroom was on the second floor. The second courthouse was constructed in 1854.

There are many distinctive elements such as the architecture, agriculture, industry, and human history that reveal just how truly unique Wayne County is.

Wayne County was in the middle of what came to be called the "Burned Over District". It was so named because so many new religious & social movements and events were happening that this fervor is said to have "set the region afire".

The Bicentennial committee's goal is to have Wayne County residents and visitors from outside Wayne County to Explore, Discover, Visit & Celebrate our unique history and heritage.

Bicentennial Committee member, Patti Holdraker is producing a monthly newsletter called "Bicentennial Bytes".

Another idea to draw attention to our Bicentennial is to have a float in local parades. The committee has the fortune to have Rose Town Supervisor Rick Lasher on the committee, Mr. Lasher, along with Huron Supervisor Phil Eygnor are heading up a group that has built the beautiful float that was completed in April and will hopefully be in many parades.

Walworth Historical Society Vice President Bob Mogray made a beautiful photo quilt for the historical society. He has volunteered to create a Wayne County Bicentennial Photo Quilt with help from the Reverse Curves Quilt Club.

The Finger Lakes Stamp Club has volunteered to head up a project to create some Bicentennial Pictorial Postal Cancellations.

The former Sodus Point Historian, Bruce Farrington is heading up a "Bicentennial Minutes" program. The Bicentennial Minutes will consist of short video presentations that will be posted on social media and on websites. The plan is to release one each week beginning in April 2022. Audio clips will be sent to radio stations and print versions to newspapers.

Amber Linson of Wayne County Writers Guild is leading a group that will be collecting Wayne County Memories. Her committee will select stories, poems and visual arts to publish in a book. The goal is to have this book ready by the fall of 2022.

Mr. Bavis spoke about all the murals featuring historical subjects. Most of the mural were created by the Mural Mania group led by Mark DeCracker. The Wayne County Bicentennial committee is planning a big mural with the "Historic to the Core" theme to be placed somewhere along Route 104.

Marion Town Historian, Caryn Devlin is leading an effort to produce a primary level activity book.

Mr. Bavis stated that the committee has come up many great ideas that they found when researching what other states and counties have done for their celebrations. The committee is going to put together a Torch Relay which should draw a lot of media attention and help promote the Bicentennial as well as get a lot of people involved with the celebration. Mr. Washburn is heading up a committee and plans to have at least 200 designated runners run 200 miles through each town in Wayne County from August 14-18, 2023 beginning and ending at the Wayne County Fair.

Another project that the committee is looking into doing is Geocaching. This one will be headed up by Lyons Town Historia Linda Guest.

The Wayne Historian Organization created an on-line database of over 1000 historic sites. In the early stages of the pandemic the committee discussed a Wayne County Challenge where they urged families to go find historic sites from the safety of their car. The committee is currently working on producing a guidebook for this activity along with some rewards for participating. The committee believes that people should know when their town was established and who or what it is named after.

Since April 11, 2023 is the official 200th birthday the Bicentennial committee is hoping to have a big celebration on that day to dedicate the historic marker, read official proclamation and much more. The committee plans to live stream it as well as record it. The committee is looking into having other big events that week as well so that people can be involved.

• Matt Tomlinson from Marathon Engineering spoke regarding the proposed Townhomes at Oakridge Glen 240-R NYS Route 31. Mr. Tomlinson spoke about the 280-unit Townhomes that Stonehaven Development, LLC would like to build. The homes would consist of two types of townhouses: there would be a 3-unit ranch town homes as well as 5-unit town homes. In addition to the townhomes there would be a clubhouse and pool with 30 parking spaces, a patio with firepit, putting green, two pickleball courts and a dog park. On the property they would also develop trails, a gazebo, playground and picnic pavilion as well as a community garden. Each residential unit will have two parking spaces — one garage and one driveway. Additional parking spaces for visitors are provided though out the development. Mr. Tomlinson stated that the development will be developed in three phases.
