WHEREAS, the Town currently collects a quarterly \$60 charge (\$240 annually) per equivalent dwelling unit ("EDU") assigned to each tax parcel, as defined and determined in accordance with Macedon Town Code \$281-43 (Local Law No. 9 of 2019), from users located within the Hamlet of Macedon Water District (the "District"), to finance the District's indebtedness and anticipated capital expenses; and

WHEREAS, in lieu of a quarterly charge, the Town Board desires to finance the District's indebtedness and capital expenses through a special assessment and

WHEREAS, said special assessment will be imposed on a benefits basis, to be determined based upon the number of EDUs assigned to each tax parcel, as defined and determined in accordance with Macedon Town Code §281-43 (Local Law No. 9 of 2019); and

WHEREAS, the Town Board presently anticipates that the collection of revenue in the amount of \$188,160 will be necessary for the Hamlet of Macedon Water District to finance the District's 2025 indebtedness and capital expenses; and

WHEREAS, the Town has determined that there are presently 784 EDUs in the Hamlet of Macedon Water District; and

WHEREAS, \$240 per EDU will be required to meet the Town's presently anticipated capital obligations for the District in 2025; and

WHEREAS, in accordance with Town Law §202, the proposed special assessment roll for the Hamlet of Macedon Water District, setting forth the anticipated special assessment to be levied upon each lot or parcel of land located therein, was created and placed on file with the Town Clerk and is available for public inspection; now therefore

BE IT RESOLVED, the Town Board shall hold a Public Hearing on October 24, 2024 at 7:10 p.m. for the purpose of hearing public comment regarding the special assessment roll for the Hamlet of Macedon Water District; and

BE IT FURTHER RESOLVED, the Town Clerk shall advertise said public hearing in accordance with Town Law §§ 202 and 239.

# **RESOLUTION NO. 216 (2024) APPLICATION OF MACEDON CSG LLC**

WHEREAS, Macedon CSG LLC, hereinafter "applicant" has advised through it attorneys an intent to lease and construct a solar farm on a 28-acre portion of the Property which is also used for more intense uses such as a sand and gravel mine, and

WHEREAS, said application was made by the attorneys for the applicant under letter of intent dated August 12, 2024 which requested a Special Use Permit from the Town Board of the Town of Macedon and Site Plan approval from the Planning Board of the Town of Macedon for this project which is as an approximately 5.00 MWAC or less ground-mounted, fixed-tilt solar photovoltaic system (FT) that generates electricity for offsite use, sale, and consumption ("Solar Array"). The Solar Array includes one pervious gravel access road, inverter pads, a fence surrounding the entirety of the equipment area, underground wiring, and overhead utility interconnection to equipment. Access is taken off the east-west diagonal bend in Walworth Road, nearly a mile north of State Highway 31, and

WHEREAS, according to the narrative, the Solar Array will disturb approximately 20.3 acres and encompass approximately 13.5 acres within the fence line. Under Ordinance § 300-187, the Solar Array is permitted on the Property through issuance of a Special Use Permit from the Town Board and Site Plan approval from the Planning Board, and

WHEREAS, the plans have been initially reviewed by the Town Engineer and Counsel to the Town who have both made recommendations to the Town Board, and

WHEREAS, the applicant appeared in person with counsel at a meeting of the Macedon Town Board held on October 10, 2024 at which meeting the applicant presented its project and answered questions from the Town Board,

#### THE APPLICATION

Based upon the review and recommendations of the Town Engineer and Counsel to the Town, the Town Board finds the application administratively complete. (Administrative completeness does not constitute completeness for SEQRA purposes).

# SEQRA

Based upon the review and recommendations of the Town Engineer and Counsel to the Town, the Town Board finds the proposed project is subject to review under the New York State Environmental Quality Review Act. (SEQRA).

Review of the SEQRA Part I demonstrates the presence of other involved and interested agencies. The Town Board hereby declares its intent to serve as lead agency and directs Town Engineer and Counsel to the Town to commence proceedings to establish the Town as Lead Agency.

Based upon the review and recommendations of the Town Engineer and Counsel to the Town, the Town Board finds the proposed project warrants a SEQRA preliminary determination as TYPE I.

# **REVIEW PROCEDURE**

The Town Board hereby refers that part of the project that requests the issuance of a Special Use Permit to the Town of Macedon Planning Board and the Wayne County Planning Board for their review and comments.

Should there be no opposition to the Town Board's declared intent to establish the Town Board as lead agency, the Town Engineer and Counsel to the Town are directed to review the project for compatibility with SEQRA and the Town Comprehensive Plan and the rules, regulations, ordinances adopted to effectuate the same and make written recommendations to the Town Board including the scheduling of a public hearing to be held tentatively on November 14, 2024 at 7:20pm the the Town Board authorizes the Town Clerk to publish the notice of said hearing in the legal paper known as the Times of Wayne County.

The Town Board hereby establishes an escrow in the amount of \$15,000 to be paid by the applicant and held in escrow by the Town of Macedon as security for reimbursement to the Town of Macedon for the costs and disbursement associated with its required review of the project.

The Town Board further authorizes and directs the Town Engineer and Counsel to the Town to develop a Host Community Agreement as is common in like applications and report its recommendations to the Town Board.

The Town Board further authorizes and directs the Town Engineer and Counsel to the Town to determine how the project will be treated for real property tax purposes and, in conjunction with the Town Assessor, report to the Town Board on the tax aspects of the project
